PURPOSE: To exhibit artworks produced collaboratively between ceramic artists and fiber artists. Fiber artists can use fabric, paper, wood, wool, yarn, or other fibrous medium. Metal can be used as a 'support' or decorative, but will not count as the fibrous medium.

ELIGIBILITY: Open to all current (2018) members of the Potter's Guild of Las Cruces (PGLC). The team consists of a clay artist who is a PGLC member and a fiber artist (which can also be a PGLC member). This is a non-juried show and all entries meeting the limitation requirements will be accepted.

PARTICIPATION FEE: \$25.00 per each team submission (consisting of one or two entries). PGLC clay artist can partner with one other fiber artist for a second submission.

APPLICATION PROCEDURE: Complete entry form. Checks should be marked payable to "Potter's Guild of Las Cruces". Mail entry form and payment to
